



The Foundation For Tomorrow (TFFT) is incorporated as a 501(c)(3) nonprofit corporation under the laws of the State of North Carolina. This raffle is conducted for the purpose of generating operating funds.

Purchases of one or more raffle tickets during TFFT's raffle will be entered into the prize drawing for a two night safari experience for two at Singita Grumeti's Sasakwa Lodge that includes a \$2,000 flight voucher. Raffle tickets are \$125 each. Odds of winning are based on the total number of tickets sold. Raffle entrants must be 18 years of age or older. Contest void where prohibited. Sweepstakes begin on July 31, 2024 and end at 2:00 p.m. on August 30, 2024 or when all 400 tickets have been sold, whichever comes first. All times referenced for the TFFT raffle are Eastern Time.

HOW TO ENTER: Go to www.thefoundationfortomorrow.org/safari-raffle and complete the online entry form and pay the entry fee with your credit card. Website sales will close at 2:00 p.m. on August 30, 2024 or when all 400 tickets have been sold, whichever comes first.

TICKET PURCHASES: Once submitted, entries become the sole property of TFFT and will not be returned or refunded.

ELIGIBILITY: Present employees of TFFT and any immediate family members residing with employees are not eligible to participate. Entrants must be 18 years or older to enter. Contest void where prohibited.

SELECTION AND NOTIFICATION OF WINNERS: Winner will be selected at random and announced on August 30, 2024. You need not be present to win. Winners will be notified by email and telephone, if necessary. If potential winner cannot be reached after 10 days from the first notification attempt, or if an entrant is found to be ineligible, or a prize notification is returned as undeliverable, such prize will be forfeited and an alternate winner will be selected by random drawing.
