**Thrive Global Project**

In Tanzania, TFFT is the operating partner for the Thrive Global Project Program. The feeding program provides students with the fuel to learn while stimulating economies through locally-sourced goods and services. The program involves using TLP funding to purchase local ingredients of maize, milk, sugar, and nuts and delivering those ingredients to the schools to make uji porridge for the school children. The feeding program is enabling a community-led, locally sourced feeding program 5 days a week to 6 schools serving over 6,000 primary school students in the Arusha City District Council.

**Teacher Training Program**

TFFT's Teacher Training Program works to ensure schools in Tanzania are better equipped to provide quality instruction to learners. We provide in-service training on child-centered instruction, participatory teaching techniques, positive behavior modification, formative assessment, planning for effective instruction, and peer mentoring and coaching.

The Teacher Training Program works with teachers and school leaders in a wide variety of programming from professional development training and effective lesson planning, to Launching Innovation in Schools, a program for school leaders to equip them with necessary tools for identifying and designing solutions for addressing unique problems within their schools. The program empowers school leaders to foster innovation and creativity within their schools, and teachers to develop individualized student-centered approaches to teaching and learning. To date, approximately 2,441 teachers were trained, impacting over 176,412 students in classrooms across

The theme of this year is "the transformation of educational systems to meet local and international needs" and is designed to provide a platform for educators to be able to explore the issues facing Tanzanian students today and learn about evidence based best-practice teaching that can meet our students where they are in their educational journey. The goal of the convention is for participants to leave with practical skills and teaching resources that
