The Learning Centre will house six distinct community learning resources, all under one roof: a free lending Library; a Literacy Lab; a Teacher Training and Resource Centre; a Technology and Computer Training Centre; a Higher Education and Advocacy Program; and an NGO and Social Entrepreneurship Incubator.

This Centre will bolster the opportunities of not only the scholars, teachers, parents and guardians that we work with, but expand our impact and introduce new educational innovations.

Teacher Training Program

TFFT's Teacher Training Program works to ensure schools in Tanzania are better equipped to provide quality instruction to learners. We provide inservice training on child-centered instruction, participatory teaching techniques, positive behavior modification, formative

assessment, planning for effective instruction, and peer mentoring and coaching. The Teacher Training Program works with teachers and school leaders in a wide variety of programming from professional development training and effective lesson planning, to Launching Innovation in Schools, a program for school leaders to equip them with necessary tools for identifying and designing solutions for addressing unique problems within their schools.

We provide in-service training on student-centered instruction, participatory teaching techniques, positive behavior modification, formative assessment, planning for effective instruction, develop model classrooms in government schools, and conduct peer mentoring and coaching for teachers. Our Teacher Training Program is designed to enhance teachers' skills to build their own activities based on the needs they identify in their schools and amongst their students in order to produce the best educational outcomes. TFFT has incorporated trainings in schools throughout four districts around Arusha under the direction of the Tanzanian Ministry of Education.

The program, some initiatives listed below, empowers school leaders to foster innovation and creativity within their schools, and teachers to develop individualized student centered approaches to teaching and learning. To date, approximately 4,500 teachers were trained, impacting over 270,000 students in classrooms across Tanzania.

TFFT's Teacher of Distinction Award incentivizes teachers through recognition and reward, motivates them to stay in the profession, strengthens their self-belief and professional identity, and encourages them to continue to transform the learning landscape. Further, the award motivates other teachers to follow leading teachers' examples and shares examples of best teaching practices with school management teams.

In searching for recipients of the award, The Foundation For Tomorrow focuses on candidates with an ability to stimulate critical and analytical thinking among students and create an engaging and rewarding learning experience. We also look for teachers that have demonstrated innovative and creative teaching methods and curriculum development. In 2024 we recognized 68 distinguished teachers with this award.
